Automotive Repair Dealer Registration

2. On or about January 7, 2010, the Bureau issued Automotive Repair Dealer
Registration Number ARD 260402 ("registration") to Gurpreet Singh ("Respondent"), doing
business as Alpine Smog. The registration was in full force and effect at all times relevant to the
charges brought herein. The license expired on October 31, 2014, and has not been renewed.

Smog Check Station License

3. On or about December 28, 2012, the Bureau issued Smog Check Station License
Number RC 260402 ("station license") to Respondent. The station license was in full force and
effect at all times relevant to the charges brought herein. The license expired on October 31,
2014, and has not been renewed.

Smog Check Repair Technician

In 2006, the Bureau issued Advanced Emission Specialist Technician License
 Number EA 153759 to Respondent. Respondent's advanced emission specialist technician
 license expired on September 30, 2012. Pursuant to California Code of Regulations, title 16,
 section 3340.28(e), the license was renewed, pursuant to Respondent's election, as Smog Check
 Repair Technician License Number EI 153759 ("repair technician license"), effective
 October 16, 2012.¹ The technician license was in full force and effect at all times relevant to the
 charges brought herein and will expire on September 30, 2016, unless renewed.

Smog Check Inspector

5. In 2006, the Bureau issued Advanced Emission Specialist Technician License
 Number EA 153759 to Respondent. Respondent's advanced emission specialist technician
 license expired on September 30, 2012. Pursuant to California Code of Regulations, title 16,
 section 3340.28(e), the license was renewed, pursuant to Respondent's election, as Smog Check
 Inspector License Number EO 153759 ("inspector license"), effective October 16, 2012. The

13	(4) Any other conduct which constitutes fraud.

21	the licensing act to pay a sum not to exceed the reasonable costs of the investigation and

23	UNDERCOVER OPERATION – SEPTEMBER 18, 2013						
24	13. On or about September 19, 2013, an undercover Bureau operator ("operator")						
25	drove a Bureau documented Chevrolet to Respondent's facility and requested a smog inspection.						
26	The vehicle could not pass the visual portion of the smog inspection because the vehicle's exhaust						
27	gas recirculation valve and exhaust gas recirculation valve cooler had been removed. When the						
28	operator arrived, he spoke with Respondent and requested a smog inspection. The operator						
	4						

signed a written estimate but did not receive a copy prior to the inspection being performed. The 1 operator then observed Respondent perform a smog inspection on the vehicle. Following the 2 inspection, Respondent told the operator that the vehicle had failed the inspection due to a 3 4 missing exhaust gas recirculation valve and exhaust gas cooler. The operator paid Respondent \$60 and received a copy of a Vehicle Inspection Report, Estimate No. 5 14. Later that same day (September 19, 2013) the Bureau conducted a field inspection 6 7 at Respondent's facility. During the field inspection, Respondent admitted and acknowledged that he had used his brother Pardeep Singh's Smog Check Inspector License Number EO 633402 8 9 and access code to perform the smog inspection on the undercover vehicle. Furthermore, Respondent knew or should have known that he was not qualified or eligible to perform the smog 10 inspection due to a low "STAR" score and that he would not have access to the EIS using his own 11 name and license information.² 12 13 FIRST CAUSE FOR DISCIPLINE (Untrue or Misleading Statements) 14 15. Respondent's registration is subject to discipline pursuant to Code section 15 16 9884.7(a)(1), in that on or about September 19, 2013, Respondent made or authorized statements which he knew or in the exercise of reasonable care should have known to be untrue or 17 misleading in that Respondent certified that his brother, Pardeep Singh, had performed the smog 18 inspection on the Bureau's 2006 Chevrolet. In fact, Respondent used his brother Pardeep Singh's 19 Smog Check Inspector License Number EO 633402 and confidential access code to access the 20 EIS and perform the smog inspection on the vehicle. 21 22 /// ||| 23 /// 24 25 ² Respondent holds Smog Check Inspector License Number EO 153759, but he is not eligible to be employed for the purposes of performing smog check inspections at a "STAR" 26 certified Smog Check Station due to a low "STAR" score. Respondent was not assigned to the Emissions Inspection System (EIS) at Alpine Smog at the time the Bureau conducted the 27 undercover vehicle operation and therefore, Respondent could not legally perform the smog inspection. 28 5

10 Technician License Number EI 153759, issued to Gurpreet Singh, is revoked or suspended, any
11 additional license issued under this chapter in the name of said licensee may be likewise revoked
12 or suspended by the Director.
