1 IT IS HEREBY STIPULATED AND AGREED by and between the parties to the above-
2 entitled proceedings that the following matters are true:

3 **PARTIES**

4 1. Patrick Dorais ("Complainant") is the Chief of the Bureau of Automotive Repair
5 ("Bureau"), Department of Consumer Affairs. He brought this action solely in his official
6 capacity and is represented in this matter by Kamala D. Harris, Attorney General of the State of
7 California, by Stephanie Alamo-Latif, Deputy Attorney General.

8 2. Gurpreet Singh, owner of Alpine Smog ("Respondent") is representing himself in this
9 proceeding and has chosen not to exercise his right to be represented by counsel.

10 **Automotive Repair Dealer Registration**

11 3. On or about January 7, 2010, the Bureau issued Automotive Repair Dealer
12 Registration Number ARD 260402 ("registration") to Gurpreet Singh ("Respondent"), doing
13 business as Alpine Smog. The registration was in full force and effect at all times relevant to the
14 charges brought herein. The license expired on October 31, 2014, and has not been renewed.

15 **Smog Check Station License**

16 4. On or about December 28, 2012, the Bureau issued Smog Check Station License
17 Number RC 260402 ("station license") to Respondent. The station license was in full force and
18 effect at all times relevant to the charges brought herein. The license expired on October 31,
19 2014, and has not been renewed.

20 **Smog Check Repair Technician**

21 5. In 2006, the Bureau issued Advanced Emission Specialist Technician License
22 Number EA 153759 to Respondent. Respondent's advanced emission specialist technician
23 license expired on September 30, 2012. Pursuant to California Code of Regulations, title 16,
24 section 3340.28(e), the license was renewed, pursuant to Respondent's election, as Smog Check
25 Repair Technician License Number EI 153759 ("repair technician license"), effective
26

1 October 16, 2012.¹ The technician license was in full force and effect at all times relevant to the
2 charges brought herein and will expire on September 30, 2016, unless renewed.

3 **Smog Check Inspector**

4 6. In 2006, the Bureau issued Advanced Emission Specialist Technician License
5 Number EA 153759 to Respondent. Respondent's advanced emission specialist technician
6 license expired on September 30, 2012. Pursuant to California Code of Regulations, title 16,
7 section 3340.28(e), the license was renewed, pursuant to Respondent's election, as Smog Check
8 Inspector License Number EO 153759 ("inspector license"), effective October 16, 2012. The
9 inspector license was in full force and effect at all times relevant to the charges brought herein
10 and will expire on September 30, 2016, unless renewed.

11 **JURISDICTION**

12 7. Accusation No. 79/15-87 was filed before the Director of Consumer Affairs
13 (Director), for the Bureau, and is currently pending against Respondent. The Accusation and all
14 other statutorily required documents were properly served on Respondent on December 23, 2014.
15 Respondent timely filed his Notice of Defense contesting the Accusation.

16 8. A copy of Accusation No. 79/15-87 is attached as exhibit A and incorporated herein
17 by reference.

18 **ADVISEMENT AND WAIVERS**

19 9. Respondent has carefully read, and understands the charges and allegations in
20 Accusation No. 79/15-87. Respondent has also carefully read, and understands the effects of this
21 Stipulated Settlement and Disciplinary Order.

22 10. Respondent is fully aware of his legal rights in this matter, including the right to a
23 hearing on the charges and allegations in the Accusation; the right to be represented by counsel at
24 his own expense; the right to confront and cross-examine the witnesses against him; the right to
25 present evidence and to testify on his own behalf; the right to the issuance of subpoenas to compel

1 the attendance of witnesses and the production of documents; the right to reconsideration and
2 court review of an adverse decision; and all other rights accorded by the California
3 Administrative Procedure Act and other applicable laws.

4 11. Respondent voluntarily, knowingly, and intelligently waives and gives up each and
5 every right set forth above.

6 CULPABILITY

7 12. Respondent admits the truth of each and every charge and allegation in Accusation
8 No. 79/15-87.

9 13. Respondent agrees that cause exists for discipline and hereby stipulates to the
10 revocation of his Automotive Repair Dealer Registration No. ARD 260402 and Smog Check
11 Station License No. RC 260402, for the Bureau's formal acceptance.

12 14. Respondent agrees that cause exists for discipline of his Smog Check Repair
13 Technician License No. EI 153759, and Smog Check Inspector License No. EO 153759 and
14 hereby agrees to be bound by the Director's probationary terms as set forth in the Disciplinary
15 Order below.

16 CONTINGENCY

17 15. This stipulation shall be subject to approval by the Director of Consumer Affairs or
18 the Director's designee. Respondent understands and agrees that counsel for Complainant and the
19 staff of the Bureau of Automotive Repair may communicate directly with the Director and staff of
20 the Department of Consumer Affairs regarding this stipulation and settlement, without notice to
21 or participation by Respondent. By signing the stipulation, Respondent understands and agrees
22 that he may not withdraw his agreement or seek to rescind the stipulation prior to the time the
23 Director considers and acts upon it. If the Director fails to adopt this stipulation as the Decision
24 and Order, the Stipulated Settlement and Disciplinary Order shall be of no force or effect, except
25 for this paragraph, it shall be inadmissible in any legal action between the parties, and the
26 Director shall not be disqualified from further action by having considered this matter.

27 16. The parties understand and agree that Portable Document Format (PDF), facsimile
28 and/or electronic copies of this Stipulated Settlement and Disciplinary Order, including PDF,

1 facsimile and/or electronic signatures thereto, shall have the same force and effect as the
2 originals.

3 17. This Stipulated Settlement and Disciplinary Order is intended by the parties to be an
4 integrated writing representing the complete, final, and exclusive embodiment of their agreement.
5 It supersedes any and all prior or contemporaneous agreements, understandings, discussions,
6 negotiations, and commitments (written or oral). This Stipulated Settlement and Disciplinary
7 Order may not be altered, amended, modified, supplemented, or otherwise changed except by a
8 writing executed by an authorized representative of each of the parties.

9 18. In consideration of the foregoing admissions and stipulations, the parties agree that
10 the Director may, without further notice or formal proceeding, issue and enter the following
11 Disciplinary Order:

12 **ORDER OF REVOCATION**

13 **Automotive Repair Dealer Registration and Smog Check Station License Only**

14 IT IS HEREBY ORDERED that Automotive Repair Dealer Registration No. ARD 260402
15 and Smog Check Station License No. RC 260402 are hereby revoked and accepted by the
16 Director of Consumer Affairs.

17 1. This stipulation constitutes a record of the discipline and shall become a part of
18 Respondent's license history with the Bureau of Automotive Repair.

19 2. Respondent shall lose all rights and privileges as an Automotive Repair Dealer and
20 Smog Check Station in California as of the effective date of the Director's Decision and Order.

21 3. Respondent shall cause to be delivered to the Bureau his pocket licenses and, if one
22 was issued, his wall certificates on or before the effective date of the Decision and Order.

23 4. If he ever applies for licensure or petitions for reinstatement of the revoked licenses in
24 the State of California, the Bureau shall treat it as a new application for licensure. Respondent
25 must comply with all the laws, regulations and procedures for licensure in effect at the time the
26 application is filed, and all of the charges and allegations contained in Accusation No. 79/15-87
27 shall be deemed to be true, correct and admitted by Respondent when the Director determines
28 whether to grant or deny the application.

5. Respondent shall not apply for licensure for one (1) year from the effective date of the Bureau's Decision and Order.

DISCIPLINARY ORDER OF PROBATION

Smog Check Repair Technician License and Smog Check Inspector License Only

IT IS HEREBY ORDERED that Smog Check Repair Technician License Number EI 153759 and Smog Check Inspector License Number EO 153759 are hereby revoked and accepted by the Director of Consumer Affairs. However, the revocation is stayed and Respondent is placed on probation for three (3) years on the following terms and conditions:

1. **Actual Suspension.** Smog Check Repair Technician License Number EI 153759 and Smog Check Inspector License Number EO 153759 issued to Respondent Gurpreet Singh are suspended for fifteen (15) days.

2. **Obey All Laws.** Comply with all statutes, regulations and rules governing automotive inspections, estimates and repairs.

3. **Post Sign.** Post a prominent sign, provided by the Bureau, indicating the beginning and ending dates of the suspension and indicating the reason for the suspension. The sign shall be conspicuously displayed in a location open to and frequented by customers and shall remain posted during the entire period of actual suspension.

4. **Reporting.** Respondent or Respondent's authorized representative must report in person or in writing as prescribed by the Bureau of Automotive Repair, on a schedule set by the Bureau, but no more frequently than each quarter, on the methods used and success achieved in maintaining compliance with the terms and conditions of probation.

5. **Report Financial Interest.** Within 30 days of the effective date of this action, report any financial interest which any partners, officers, or owners of the Respondent facility may have in any other business required to be registered pursuant to Section 9884.6 of the Business and Professions Code.

6. **Random Inspections.** Provide Bureau representatives unrestricted access to inspect all vehicles (including parts) undergoing repairs, up to and including the point of completion.

7. **Jurisdiction.** If an accusation is filed against Respondent during the term of

1 probation, the Director of Consumer Affairs shall have continuing jurisdiction over this matter
2 until the final decision on the accusation, and the period of probation shall be extended until such
3 decision.

4 **8. Violation of Probation.** Should the Director of Consumer Affairs determine that
5 Respondent has failed to comply with the terms and conditions of probation, the Department may,
6 after giving notice and opportunity to be heard, may set aside the stay order and impose the
7 stayed discipline (revocation) of Respondent's license.

8 If during the period of probation, an accusation or petition to revoke probation has been
9 filed against Respondent's license or the Attorney General's Office has been requested to prepare
10 an accusation or petition to revoke probation against Respondent's license, the probationary
11 period shall automatically be extended and shall not expire until the accusation or petition has
12 been acted upon by the Bureau.

13 **9. Continuing Education Courses.** During the period of probation, Respondent shall
14 attend and successfully complete a Bureau certified inspector level 1 training course. Said course
15 shall be completed and proof of completion submitted to the Bureau within 180 days of the
16 effective date of this decision and order. If proof of completion of the course is not furnished to
17 the Bureau within the 180-day period, Respondents' license shall be immediately suspended until
18 such proof is received.

19 **10. Cost Recovery.** Respondent shall pay to the Bureau costs associated with its
20 investigation and enforcement pursuant to Business and Professions Code section 125.3 in the
21 amount of \$5,000. Respondent shall be permitted to pay these costs in 24 consecutive, equal
22 monthly installments with the final payment due 12 months prior to the termination of probation.
23 Failure to complete payment of cost recovery within this time frame shall constitute a violation of
24 probation which may subject Respondent's Smog Check Repair Technician License and Smog
25 Check Inspector License to outright revocation; however, the Director or the Director's Bureau of
26 Automotive Repair designee may elect to continue probation until such time as reimbursement of
27 the entire cost recovery amount has been made to the Bureau.

ACCEPTANCE

I have carefully read the Stipulated Settlement and Disciplinary Order. I understand the stipulation and the effect it will have on my Automotive Repair Dealer Registration, Smog Check Station License, Smog Check Repair Technician License, and Smog Check Inspector License. I enter into this Stipulated Settlement and Disciplinary Order voluntarily, knowingly, and intelligently, and agree to be bound by the Decision and Order of the Director of Consumer Affairs.

25 **PARTIES**

26 1. Complainant brings this Accusation solely in his official capacity as the Chief of the
27 Bureau of Automotive Repair ("Bureau"), Department of Consumer Affairs.

28 ///

1 **Automotive Repair Dealer Registration**

2 2. On or about January 7, 2010, the Bureau issued Automotive Repair Dealer
3 Registration Number ARD 260402 ("registration") to Gurpreet Singh ("Respondent"), doing
4 business as Alpine Smog. The registration was in full force and effect at all times relevant to the
5 charges brought herein. The license expired on October 31, 2014, and has not been renewed.

6 **Smog Check Station License**

7 3. On or about December 28, 2012, the Bureau issued Smog Check Station License
8 Number RC 260402 ("station license") to Respondent. The station license was in full force and
9 effect at all times relevant to the charges brought herein. The license expired on October 31,
10 2014, and has not been renewed.

11 **Smog Check Repair Technician**

12 4. In 2006, the Bureau issued Advanced Emission Specialist Technician License
13 Number EA 153759 to Respondent. Respondent's advanced emission specialist technician
14 license expired on September 30, 2012. Pursuant to California Code of Regulations, title 16,
15 section 3340.28(e), the license was renewed, pursuant to Respondent's election, as Smog Check
16 Repair Technician License Number EI 153759 ("repair technician license"), effective
17 October 16, 2012.¹ The technician license was in full force and effect at all times relevant to the
18 charges brought herein and will expire on September 30, 2016, unless renewed.

19 **Smog Check Inspector**

20 5. In 2006, the Bureau issued Advanced Emission Specialist Technician License
21 Number EA 153759 to Respondent. Respondent's advanced emission specialist technician
22 license expired on September 30, 2012. Pursuant to California Code of Regulations, title 16,
23 section 3340.28(e), the license was renewed, pursuant to Respondent's election, as Smog Check
24 Inspector License Number EO 153759 ("inspector license"), effective October 16, 2012. The
25

1 inspector license was in full force and effect at all times relevant to the charges brought herein
2 and will expire on September 30, 2016, unless renewed.

3 **STATUTORY PROVISIONS**

4 6. Section 9884.7 of the Business and Professions Code ("Code") states, in pertinent
5 part:

6 (a) The director, where the automotive repair dealer cannot show there was a
7 bona fide error, may deny, suspend, revoke, or place on probation, the registration of
8 an automotive repair dealer for any of the following acts or omissions related to the
9 conduct of the business of the automotive repair dealer, which are done by the
automotive repair dealer or any automotive technician, employee, partner, officer, or
member of the automotive repair dealer.

10 (1) Making or authorizing in any manner or by any means whatever any
11 statement written or oral which is untrue or misleading, and which is known, or which
by the exercise of reasonable care should be known, to be untrue or misleading.

12 (3) Failing or refusing to give to a customer a copy of any document
13 requiring his or her signature, as soon as the customer signs the document.

14 (4) Any other conduct which constitutes fraud.

15 (b) Except as provided for in subdivision (c), if an automotive repair dealer
operates more than one place of business in this state, the director pursuant to
16 subdivision (a) shall only suspend, revoke, or place on probation the registration of
the specific place of business which has violated any of the provisions of this chapter.
This violation, or action by the director, shall not affect in any manner the right of the
17 automotive repair dealer to operate his or her other places of business.

18 (c) Notwithstanding subdivision (b), the director may suspend, revoke, or
19 place on probation, the registration for all places of business operated in this state by
an automotive repair dealer upon a finding that the automotive repair dealer has, or is,
engaged in a course of repeated and willful violations of this chapter, or regulations
20 adopted pursuant to it.

21 7. Section 9884.13 of the Code states:

22 "The expiration of a valid registration shall not deprive the director or chief of jurisdiction
23 to proceed with any investigation or disciplinary proceeding against an automotive repair dealer
24 or to render a decision invalidating a registration temporarily or permanently."

25 8. Section 44002 of the Health and Safety Code provides, in pertinent part, that the
26 Director has all the powers and authority granted under the Automotive Repair Act for enforcing
27 the Motor Vehicle Inspection Program.

28 ///

9. Section 44072.2 of the Health and Safety Code states, in pertinent part:

The director may suspend, revoke, or take other disciplinary action against a license as provided in this article if the licensee, or any partner, officer, or director thereof, does any of the following:

(a) Violates any section of this chapter [the Motor Vehicle Inspection Program (Health and Saf. Code, § 44000, et seq.)] and the regulations adopted pursuant to it, which related to the licensed activities.

(c) Violates any of the regulations adopted by the director pursuant to this chapter.

(d) Commits any act involving dishonesty, fraud, or deceit whereby another is injured.

10. Section 44072.6 of the Health and Safety Code provides, in pertinent part, that the expiration or suspension of a license by operation of law, or by order or decision of the Director of Consumer Affairs, or a court of law, or the voluntary surrender of the license shall not deprive the Director of jurisdiction to proceed with disciplinary action.

11. Section 44072.8 of the Health and Safety Code states:

"When a license has been revoked or suspended following a hearing under this article, any additional license issued under this chapter in the name of the licensee may be likewise revoked or suspended by the director."

COST RECOVERY

12. Code section 125.3 provides, in pertinent part, that a Board may request the administrative law judge to direct a licensee found to have committed a violation or violations of the licensing act to pay a sum not to exceed the reasonable costs of the investigation and enforcement of the case.

UNDERCOVER OPERATION – SEPTEMBER 18, 2013

13. On or about September 19, 2013, an undercover Bureau operator ("operator") drove a Bureau documented Chevrolet to Respondent's facility and requested a smog inspection. The vehicle could not pass the visual portion of the smog inspection because the vehicle's exhaust gas recirculation valve and exhaust gas recirculation valve cooler had been removed. When the operator arrived, he spoke with Respondent and requested a smog inspection. The operator

1 signed a written estimate but did not receive a copy prior to the inspection being performed. The
2 operator then observed Respondent perform a smog inspection on the vehicle. Following the
3 inspection, Respondent told the operator that the vehicle had failed the inspection due to a
4 missing exhaust gas recirculation valve and exhaust gas cooler. The operator paid Respondent
5 \$60 and received a copy of a Vehicle Inspection Report, Estimate N [REDACTED] and Invoice [REDACTED]

6 14. Later that same day (September 19, 2013) the Bureau conducted a field inspection
7 at Respondent's facility. During the field inspection, Respondent admitted and acknowledged
8 that he had used his brother Pardeep Singh's Smog Check Inspector License Number EO 633402
9 and access code to perform the smog inspection on the undercover vehicle. Furthermore,
10 Respondent knew or should have known that he was not qualified or eligible to perform the smog
11 inspection due to a low "STAR" score and that he would not have access to the EIS using his own
12 name and license information.²

13 **FIRST CAUSE FOR DISCIPLINE**

14 **(Untrue or Misleading Statements)**

15 15. Respondent's registration is subject to discipline pursuant to Code section
16 9884.7(a)(1), in that on or about September 19, 2013, Respondent made or authorized statements
17 which he knew or in the exercise of reasonable care should have known to be untrue or
18 misleading in that Respondent certified that his brother, Pardeep Singh, had performed the smog
19 inspection on the Bureau's 2006 Chevrolet. In fact, Respondent used his brother Pardeep Singh's
20 Smog Check Inspector License Number EO 633402 and confidential access code to access the
21 EIS and perform the smog inspection on the vehicle.

24 ///

25 ² Respondent holds Smog Check Inspector License Number EO 153759, but he is not
26 eligible to be employed for the purposes of performing smog check inspections at a "STAR"
27 certified Smog Check Station due to a low "STAR" score. Respondent was not assigned to the
28 Emissions Inspection System (EIS) at Alpine Smog at the time the Bureau conducted the
undercover vehicle operation and therefore, Respondent could not legally perform the smog
inspection.

1 **SECOND CAUSE FOR DISCIPLINE**

2 **(Fraud)**

3 16. Respondent's registration is subject to discipline pursuant to Code section
4 9884.7(a)(4), in that on or about September 19, 2013, regarding the 2006 Chevrolet, Respondent
5 committed acts which constitute fraud by using his brother, Pardeep Singh's Smog Check
6 Inspector License Number EO 633402 and confidential access code to access the EIS and enter
7 false information into the unit concerning the identity of the technician performing the smog
8 inspection on the Bureau's undercover vehicle. Furthermore, Respondent knew or should have
9 known that he was not qualified or eligible to perform the smog inspection due to a low "STAR"
10 score and that he would not have access to the EIS using his own name and license information.
11 Therefore, a bona fide inspection of the emission control devices and systems on the vehicle was
12 not performed, thereby depriving the People of the State of California of the protection afforded
13 by the Motor Vehicle Inspection Program.

14 **THIRD CAUSE FOR DISCIPLINE**

15 **(Failure to Provide a Copy of a Signed Document)**

16 17. Respondent's registration is subject to discipline under Code section 9884.7(a)(3),
17 in that on or about September 19, 2013, regarding the Chevrolet, Respondent failed to provide the
18 operator with a copy of the estimate as soon as the operator signed the document.

19 **FOURTH CAUSE FOR DISCIPLINE**

20 **(Violations of the Motor Vehicle Inspection Program)**

21 18. Respondent's station license and inspector license are subject to discipline under
22 Health & Safety Code section 44072.2(a), in that on or about September 19, 2013, regarding the
23 Chevrolet, Respondent failed to comply with the following sections of that Code:

24 a. **Section 44012(f):** Respondent failed to perform emission control tests on the
25 vehicle in accordance with procedures prescribed by the department.

1 b. Section 44014(a): Respondent used his brother, Pardeep Singh's Smog Check
2 Inspector License Number EO 633402 and confidential access code to access the EIS and enter
3 false information into the unit concerning the identity of the technician performing the smog
4 inspection on the Bureau's undercover vehicle.

5 **FIFTH CAUSE FOR DISCIPLINE**

6 **(Failure to Comply with Regulations)**

7 19. Respondent's station license and inspector license are subject to discipline under
8 Health & Safety Code section 44072.2(c), in that on or about September 19, 2013, regarding the
9 Chevrolet, Respondent failed to comply with provisions of California Code of Regulations, title
10 16, as follows:

11 a. Section 3340.41(b): Respondent used his brother, Pardeep Singh's Smog Check
12 Inspector License Number EO 633402 and confidential access code to access the EIS and enter
13 false information into the unit concerning the identity of the technician performing the smog
14 inspection on the Bureau's undercover vehicle.

15 b. Section 3340.42: Respondent failed to conduct the required smog tests on the
16 vehicle in accordance with the Bureau's specifications.

17 **SIXTH CAUSE FOR DISCIPLINE**

18 **(Dishonesty, Fraud or Deceit)**

19 20. Respondent's station license, repair technician license, and inspector license are
20 subject to discipline under Health & Safety Code section 44072.2(d), in that on or about
21 September 19, 2013, Respondent committed dishonest, fraudulent or deceitful acts whereby
22 another was injured, as more particularly set forth above in paragraphs 15 and 16.

23 **OTHER MATTERS**

24 21. Pursuant to Code section 9884.7(c), the director may suspend, revoke, or place on
25 probation the registrations for all places of business operated in this state by Gurpreet Singh, upon
26 a finding that he has, or is, engaged in a course of repeated and willful violation of the laws and
27 regulations pertaining to an automotive repair dealer.

28 ///

22. Pursuant to Health and Safety Code section 44072.8, if Smog Check Station License Number RC 260402, issued to Gurpreet Singh, doing business as Alpine Smog, is revoked or suspended, any additional license issued under this chapter in the name of said licensee may be likewise revoked or suspended by the director.

23. Pursuant to Health and Safety Code section 44072.8, if Smog Check Inspector License Number EO 153759, issued to Gurpreet Singh, is revoked or suspended, any additional license issued under this chapter in the name of said licensee may be likewise revoked or suspended by the Director.

24. Pursuant to Health and Safety Code section 44072.8, if Smog Check Repair Technician License Number EI 153759, issued to Gurpreet Singh, is revoked or suspended, any additional license issued under this chapter in the name of said licensee may be likewise revoked or suspended by the Director.

PRAYER

WHEREFORE, Complainant requests that a hearing be held on the matters herein alleged, and that following the hearing, the Director of Consumer Affairs issue a decision;

1. Revoking, suspending, or placing on probation Automotive Repair Dealer Registration No. ARD 260402, issued to Gurpreet Singh, doing business as Alpine Smog;

2. Revoking, suspending, or placing on probation any other automotive repair dealer registration issued to Gurpreet Singh;

3. Revoking, suspending, or placing on probation Smog Check Station License Number RC 260402, issued to Gurpreet Singh, doing business as Alpine Smog;

4. Revoking, suspending, or placing on probation Smog Check Repair Technician License Number EI 153759, issued to Gurpreet Singh;

5. Revoking, suspending, or placing on probation Smog Check Inspector License
Number EO 153759, issued to Gurpreet Singh;

6. Revoking, suspending, or placing on probation any additional license issued under chapter 5, of the Health and Safety Code in the name of Gurpreet Singh;
