PARTIES

1. Patrick Dorais (Complainant) brings this Accusation solely in his official capacity as the Chief of the Bureau of Automotive Repair (Bureau), Department of Consumer Affairs.

Automotive Repair Dealer Registration

2. On November 9, 2011, the Bureau issued Automotive Repair Dealer Registration Number ARD 267117 (registration) to Quick Tune & Brake, Inc. with Shafiullah Wardak as President. (Respondent Quick Tune & Brake, Inc.). The registration was in full force and effect at all times relevant to the charges brought within this Accusation and will expire on November 30, 2020, unless renewed.

Lamp Station License

3. On March 28, 2012, the Bureau issued Lamp Station License Number LS 267117, Class A, to Respondent Quick Tune & Brake, Inc., with Shafiullah Wardak as President. The license was in full force and effect at all times relevant to the charges brought within this Accusation and will expire on November 30, 2020, unless renewed.

Brake Station License

4. On March 28, 2012, the Bureau issued Brake Station License Number BS 267117, Class C, to Respondent Quick Tune & Brake, Inc., with Shafiullah Wardak as President. The license was in full force and effect at all times relevant to the charges brought within this Accusation, and will expire on November 30, 2020, unless renewed.

Smog Check Station License

5. On March 28, 2012, the Bureau issued Smog Check Station License Number RC 267117 to Respondent Quick Tune & Brake, Inc., with Shafiullah Wardak as President. The license was in full force and effect at all times relevant to the charges brought within this Accusation and will expire on November 30, 2020, unless renewed.

Smog Check Inspector License

6. On or about September 4, 2013, the Bureau issued Smog Check Inspector License Number EO 30707 to Respondent Shafiulllah Shirzoy Wardak (Respondent Wardak). The

license was in full force and effect at all times relevant to the charges brought within this Accusation and will expire on August 31, 2021, unless renewed.

Smog Check Repair Technician License

7. On or about September 4, 2013, the Bureau issued Smog Check Repair Technician License Number EI 30707 to Respondent Wardak. The license was in full force and effect at all times relevant to the charges brought within this Accusation, and is delinquent.

Brake Adjustor License

8. In or about 1997, the Bureau issued Brake Adjuster License Number BA 30707, Class C to Respondent Wardak. The license was in full force and effect at all times relevant to the charges brought within this Accusation; it expired on August 31, 2018; but has since been renewed, and will expire on August 31, 2022, unless renewed.

Lamp Adjuster License

9. In or about 1997, the Bureau issued Lamp Adjuster License Number LA 30707, Class A, to Respondent Wardak. The license was in full force and effect at all times relevant to the charges brought within this Accusation, and will expire on August 31, 2021, unless renewed.

JURISDICTION

- 10. This Accusation is brought before the Director of the Department of Consumer Affairs (Director) for the Bureau of Automotive Repair, under the authority of the following laws. All section references are to the Business and Professions Code (Code) unless otherwise indicated.
 - 11. Code section 118, subdivision (b), states:

"The suspension, expiration, or forfeiture by operation of law of a license issued by a board in the department, or its suspension, forfeiture, or cancellation by order of the board or by order of a court of law, or its surrender without the written consent of the board, shall not, during any period in which it may be renewed, restored, reissued, or reinstated, deprive the board of its authority to institute or continue a disciplinary proceeding against the licensee upon any ground provided by law or to enter an order suspending or revoking the license or otherwise taking disciplinary action against the licensee on any such ground."

12. Code section 9882, subdivision (a), states in part:

"There is in the Department of Consumer Affairs a Bureau of Automotive Repair under the supervision and control of the director. The duty of enforcing and administering this chapter is vested in the chief who is responsible to the director. The director may adopt and enforce those rules and regulations that he or she determines are reasonably necessary to carry out the purposes of this chapter and declaring the policy of the bureau, including a system for the issuance of citations for violations of this chapter as specified in Section 125.9."

13. Code section 9884.13 states:

"The expiration of a valid registration shall not deprive the director or chief of jurisdiction to proceed with any investigation or disciplinary proceeding against an automotive repair dealer or to render a decision invalidating a registration temporarily or permanently."

- 14. Code section 9889.1 states, in relevant part, that the Director may suspend or revoke any license issued under Articles 5 and 6 (commencing with section 9887.1) of the Automotive Repair Act.
- 15. Code section 9889.7 states, in relevant part, that the expiration or suspension of a license by operation of law or by order or decision of the Director or a court of law, or the voluntary surrender of a license shall not deprive the Director of jurisdiction to proceed with any disciplinary proceedings.
- 16. Code section 9889.9 states, in relevant part, that when any license has been revoked or suspended following a hearing under the provisions of this article, any additional license issued under Articles 5 and 6 of this chapter in the name of the licensee may be likewise revoked or suspended by the director.
- 17. Code section 477 states, in relevant part, that "Board" includes "bureau," "commission," "committee," "department," "division," "examining committee," "program," and "agency." "License" includes certificate, registration or other means to engage in a business or profession regulated by the code.

STATUTORY PROVISIONS

18. Code section 9884.7 states, in relevant part:

- (a) The director, where the automotive repair dealer cannot show there was a bona fide error, may deny, suspend, revoke, or place on probation the registration of an automotive repair dealer for any of the following acts or omissions related to the conduct of the business of the automotive repair dealer, which are done by the automotive repair dealer or any automotive technician, employee, partner, officer, or member of the automotive repair dealer.
- (1) Making or authorizing in any manner or by any means whatever any statement written or oral which is untrue or misleading, and which is known, or which by the exercise of reasonable care should be known, to be untrue or misleading.

. . . .

- (4) Any other conduct which constitutes fraud.
- (5) Conduct constituting gross negligence.
- (6) Failure in any material respect to comply with the provisions of this chapter or regulations adopted pursuant to it.
- (7) Any willful departure from or disregard of accepted trade standards for good and workmanlike repair in any material respect, which is prejudicial to another without consent of the owner or his or her duly authorized representative.

. . . .

- (c) Notwithstanding subdivision (b), the director may suspend, revoke, or place on probation the registration for all places of business operated in this state by an automotive repair dealer upon a finding that the automotive repair dealer has, or is, engaged in a course of repeated and willful violations of this chapter, or regulations adopted pursuant to it.
 - 19. Code section 9887.1, subdivision (a) states, in relevant part:
- (a) Persons whose licenses have expired shall immediately cease the activity requiring a license, but the director shall accept applications for renewal during the 30-day period following the date of expiration if they are accompanied by a new license fee. In no case shall a license be renewed where the application is received more than 30 days after the date of expiration.
- 20. Code section 9889.3 states, in relevant part:

The director may suspend, revoke, or take other disciplinary action against a license as provided in this article [Article 7 (commencing with section 9889.1) of Chapter 20.3 of Division 3 of the Business and Professions Code] if the licensee or any partner, officer, or director thereof:

(a) Violates any section of the Business and Professions Code which relates to his or her licensed activities.

7	21. Code section 9889.16 states:

11	name of the owner of the vehicle, and the official license of the station.
12	22. Code section 9889.22 states:
13 14	The willful making of any false statement or entry with regard to a material matter in any oath, affidavit, certificate of compliance or noncompliance, or
15	application form which is required by this chapter [the Automotive Repair Act] or Chapter 5 (commencing with Section 44000) of Part 5 of Division 26 of the Health and Safety Code constitutes perjury and is punishable as provided in the Penal Code.

17	23. Health and Safety Code section 44072.2 states, in relevant part:

REGULATORY PROVISIONS

- 24. California Code of Regulations, title 16, section 3305, subdivision (a) states that all adjusting, inspecting, servicing, and repairing of brake systems and lamp systems for the purpose of issuing any certificate of compliance or adjustment shall be performed in official stations, by official adjusters, in accordance with specified procedures.
- 25. California Code of Regulations, title 16, section 3316, subdivision (d)(2) states: "Where all of the lamps, lighting equipment, and related electrical systems on a vehicle have been inspected and found in compliance with all requirements of the Vehicle Code and bureau regulations, the certificate shall certify that the entire system meets all such requirement."
- 26. California Code of Regulations, title 16, section 3321, subdivision (c)(2) provides, in relevant part: "Where the entire brake system on any vehicle has been inspected or tested and found in compliance with all requirements of the Vehicle Code and bureau regulations, and the vehicle has been road-tested, the certificate shall certify that the entire system meets all such requirements."
 - 27. California Code of Regulations, title 16, section 3340.24, subdivision (c), provides:
- "(c) The bureau may suspend or revoke the license of or pursue other legal action against a licensee, if the licensee falsely or fraudulently issues or obtains a certificate of compliance or a certificate of noncompliance."
 - 28. California Code of Regulations, title 16, section 3340.30, provides, in relevant part:
- "A smog check technician shall comply with the following requirements at all times while licensed.
- "(a) A licensed technician shall inspect, test and repair vehicles in accordance with section 44012 of the Health and Safety Code, section 44035 of the Health and Safety Code, and section 3340.42 of this article."
 - 29. California Code of Regulations, title 16, section 3340.35, subdivision (c), states:
- "(c) A licensed station shall issue a certificate of compliance or noncompliance to the owner or operator of any vehicle that has been inspected in accordance with the procedures

specified in section 3340.42 of this article and has all the required emission control equipment and devices installed and functioning correctly."

- 30. California Code of Regulations, title 16, section 3340.41, subdivision (c), states:
- "(c) No person shall enter into the emissions inspection system any vehicle identification information or emission control system identification data for any vehicle other than the one being tested. Nor shall any person knowingly enter into the emissions inspection system any false information about the vehicle being tested."
 - 31. California Code of Regulations, title 16, section 3371 states:

"No dealer shall publish, utter, or make or cause to be published, uttered, or made any false or misleading statement or advertisement which is known to be false or misleading, or which by the exercise of reasonable care should be known to be false or misleading..."

32. California Code of Regulations, title 16, section 3373, states:

"No automotive repair dealer or individual in charge shall, in filling out an estimate, invoice, or work order, or record required to be maintained by section 3340.15(f) of this chapter, withhold therefrom or insert therein any statement or information which will cause any such document to be false or misleading, or where the tendency or effect thereby would be to mislead or deceive customers, prospective customers, or the public."

COST RECOVERY

33. Code section 125.3 states, in relevant part, that the Board may request the administrative law judge to direct a licentiate found to have committed a violation or violations of the licensing act to pay a sum not to exceed the reasonable costs of the investigation and enforcement of the case, with failure of the licentiate to comply subjecting the license to not being renewed or reinstated. If a case settles, recovery of investigation and enforcement costs may be included in a stipulated settlement.

FIRST UNDERCOVER OPERATION: 2001 FORD

34. On August 14, 2018, at approximately 10:45 a.m., a Bureau undercover operator (operator) drove a Bureau-documented 2001 Ford to Quick Tune & Brake, Inc. and requested brake and lamp inspections. The Quick Tune & Brake, Inc., representative, Sean, confirmed that

the fee to inspect the brake and lamp systems in the Ford would be \$89.00, and that the inspections would take one to one and one half hours to complete. The operator approved and signed the work order, and left the Ford at Quick Tune & Brake, Inc. for the inspections.

- 35. Previously, in July 2018, a Bureau Forensic Documentation Laboratory (Doc Lab) Representative removed and replaced the Ford's left front brake rotor and right rear brake drum with an undersized brake rotor and an oversized brake drum, intentionally creating defects in the Ford's brake system. Because of the defect introduced by the Bureau Doc Lab Representative to the Ford's left front brake rotor, the brake rotor measured under the minimum manufacture service specifications. Because of the defect introduced by the Bureau Doc Lab Representative to the Ford's right rear brake drum, the brake drum measured over the maximum manufacturer service specifications. The Bureau Doc Lab Representative installed and photographed tamper indicators on all four wheels to detect removal. The Bureau Doc Lab Representative also adjusted both low beam headlamp patterns in the Ford's headlamps to be approximately 12 inches below the maximum specification provided by the Bureau's Handbook for Lamp Adjusting Stations¹ (Lamp Adjusters Handbook). Because of the defect introduced by the Bureau Doc Lab Representative to the Ford's headlamps, the headlamp patterns were out of compliance with lamp adjuster specifications. The Bureau Doc Lab Representative installed and photographed tamper indicators on the headlamp adjuster assemblies to detect removal.
- 36. At approximately 12:55 p.m. on August 14, 2018, the operator returned to Quick Tune & Brake, Inc. to retrieve the Ford. After paying the \$89.00 invoice for the lamp and brake inspections, the operator received a copy of the invoice and the following certificates:
 - a. Certificate of Compliance Lamp Adjustment No. LA 2853733
 - b. Certificate of Compliance Brake Adjustment No. BA 2890398
- 37. On August 20, 2018, the Bureau Doc Lab Representative re-inspected the Ford, after reviewing the invoice and certificates of compliance. Based on the re-inspection, the Bureau Doc Lab Representative determined the following:

¹ According to the handbook's introduction, "The objective [of the handbook] is to provide uniformity in the licensing of stations and adjusters, and in the adjusting, servicing and inspecting of vehicle lighting equipment to ensure the safety of the motoring public."

a. Respondent Quick Tune & Brake, Inc. certified under penalty of perjury on Brake Adjustment Number BA 2890398 and Lamp Adjustment Number LA 2853733 that the applicable inspections were performed on the brake and lamp systems on the Bureau's Ford. In fact, Respondent Quick Tune & Brake, Inc. failed to properly inspect the lamps and brakes on the Ford, as more fully explained in paragraphs 34-38, above.

SECOND CAUSE FOR DISCIPLINE

(Fraud)

40. Respondent Quick Tune & Brake, Inc. has subjected its Automotive Repair Dealer Registration to disciplinary action for fraud under Code section 9884.7, subdivision (a)(4), in that Respondent Quick Tune & Brake, Inc. committed acts which constitute fraud, as follows: Respondent Quick Tune & Inc. charged and obtained an \$89.00 payment from the operator for performing the applicable inspection, adjustment, or repair of the brake and lamp systems on the Bureau's Ford; however, the inspections were not performed, or were inadequately performed, and Respondent fraudulently issued certificates of compliance that should not have issued, constituting acts of fraud. The circumstances are more fully explained in paragraphs 34-38, above.

THIRD CAUSE FOR DISCIPLINE

(Gross Negligence)

41. Respondent Quick Tune & Brake, Inc. has subjected its Automotive Repair Dealer Registration to disciplinary action for gross negligence under Code section 9884.7, subdivision (a)(5) in that Respondent failed to competently inspect the brake and lighting systems on the Bureau's 2001 Ford and issued certificates of compliance for brake adjustment and lamp adjustment when both the brake and lighting systems should not have passed the inspections because they should have failed compliance criteria. By failing to adhere to the inspection and certification criteria specified in the Bureau's Handbooks for Brake and Lamp Adjusters, Respondent Quick Tune & Brake, Inc. was grossly negligent. The circumstances are more fully explained in paragraphs 34-38, above.

FOURTH CAUSE FOR DISCIPLINE

(Failure to comply with Automotive Repair Act)

- 42. Respondent Quick Tune & Brake, Inc. has subjected its Automotive Repair Dealer Registration to disciplinary action for failing to comply with the Automotive Repair Act under Code section 9884.7, subdivision (a)(6) in that Respondent Quick Tune & Brake, Inc. failed to properly perform brake and lamp inspections on the Bureau's 2001 Ford. In doing so, Respondent failed to comply with provisions of the Code in the following material respects:
- a. <u>Code section 9889.16</u>: Respondent issued Brake Certificate of Compliance Number BA 2890398 and Lamp Certificate of Compliance Number LA 2853733 for the Bureau's 2001 Ford; however, the vehicle did not comply with Vehicle Code requirements or Bureau regulations.
- b. <u>Code section 9889.22</u>: Respondent willfully made false statements or entries on Brake
 Certificate of Compliance Number BA 2890398 and Lamp Certificate of Compliance Number
 LA 2853733, in violation of the Automotive Repair Act.

The circumstances establishing Respondent's failure to comply with the Automotive Repair Act are more fully explained in paragraphs 34-38, above.

FIFTH CAUSE FOR DISCIPLINE

(Violation of Regulations)

- 43. Respondent Quick Tune & Brake, Inc. has subjected its Automotive Repair Dealer Registration to disciplinary action for failing to comply with the Automotive Repair Act under Code section 9884.7, subdivision (a)(6) in that Respondent Quick Tune & Brake, Inc. failed to comply with the provisions of the California Code of Regulations, title 16, in the following material respects:
- a. <u>Section 3305</u>, <u>subdivision (a)</u>: Respondent Quick Tune & Brake, Inc. failed to perform the inspections of the brake and lamp systems on the Bureau's 2001 Ford in accordance with the specifications, instructions, and directives issued by the Bureau and the vehicle manufacturer.
- b. <u>Section 3316, subdivision (d)(2)</u>: Respondent Quick Tune & Brake, Inc. issued Lamp Certificate of Compliance Number LA 2853733 for the Bureau's 2001 Ford when the lamps were not in compliance with Bureau regulations.

TWELFTH CAUSE FOR DISCIPLINE

(Committing an Act Involving Dishonesty, Fraud, or Deceit)

50. Respondent Wardak has subjected his brake and lamp adjuster licenses to disciplinary action pursuant to Code section 9889.3, subdivision (d) in that Respondent Wardak committed acts involving dishonesty, fraud, or deceit when he issued certificates of brake and lamp compliance that fraudulently reflected that the 2001 Ford's brake and lamp systems were in compliance when they were not. The circumstances are more fully explained in paragraphs 34-38, above.

THIRTEENTH CAUSE FOR DISCIPLINE

(Violation of Lamp and Brake Laws Relating to Licensing)

51. Respondent Wardak has subjected his brake and lamp adjuster licenses to disciplinary action pursuant to Code section 9889.3, subdivision (h) in that Respondent Wardak issued Brake Certificate of Compliance Number BA 2890398 and Lamp Certificate of Compliance Number LA 2853733, when neither the 2001 Ford's brake system nor its lamp system was actually in compliance. The circumstances are more fully explained in paragraphs 34-38, above.

FOURTEENTH CAUSE FOR DISCIPLINE

(Failure to Properly Perform a Brake and Lamp Inspection)

52. Respondent Wardak has subjected his brake and lamp adjuster licenses to disciplinary action pursuant to Code section 9889.16 in that Respondent Wardak failed to inspect the left front brake rotor, the right rear brake drum, and the headlight aim on the 2001 Ford. The circumstances are more fully explained in paragraphs 34-38, above.

FIFTEENTH CAUSE FOR DISCIPLINE

(Willfully Making a False Statement on a Certificate of Compliance)

53. Respondent Wardak has subjected his brake and lamp adjuster licenses to disciplinary action pursuant to Code section 9889.22 in that Respondent Wardak issued Brake Certificate of Compliance Number BA 2890398 and Lamp Certificate of Compliance Number LA 2853733 when neither the brake system nor the lamp system on the 2001 Ford was actually in compliance. The circumstances are more fully explained in paragraphs 34-38, above.

SMOG CHECK INSPECTOR LICENSE NUMBER EO 30707 AND SMOG CHECK REPAIR TECHNICIAN LICENSE NUMBER EI 30707 SPECIFIC TO RESPONDENT SHAFIULLAH WARDAK

SIXTEENTH CAUSE FOR DISCIPLINE

(Dishonesty, Fraud or Deceit)

- 54. Respondent Wardak has subjected his smog check inspector license to disciplinary action pursuant to Health and Safety Code section 44072.2, subdivision (d), in that Respondent Wardak committed dishonest, fraudulent, and/or deceitful acts resulting in the injury to another, as more fully set forth in paragraphs 34-38, above.
- 55. Respondent Wardak has subjected his smog check repair technician license to disciplinary action pursuant to Health and Safety Code section 44072.2, subdivision (d), in that Respondent Wardak committed dishonest, fraudulent, and/or deceitful acts resulting in the injury to another, as more fully set forth in paragraphs 34-38, above.

SECOND UNDERCOVER OPERATION: 2007 TOYOTA

- 56. On February 21, 2019, at approximately 10:47 a.m., an undercover operator (operator) with the Bureau took the Bureau's 2007 Toyota to Quick Tune & Brake, Inc. and requested brake and lamp inspections. In January and February 2019, a Bureau Forensic Documentation Laboratory (Doc Lab) Representative replaced the right front brake rotor with a brake rotor under the minimum manufacture service specifications. At the same time, the Bureau Doc Lab Representative replaced the left rear brake rotor with a brake rotor under the minimum manufacturer service specifications, and misadjusted the right and left low beam headlamps excessively down, so that both headlights were out of specification.
- 57. Upon arriving at Quick Tune & Brake Inc., the operator met with Respondent Wardak. Respondent Wardak confirmed that the fee to inspect the brake and lamp systems in the 2007 Toyota would be \$90.00. The operator signed the work order, and left the 2007 Toyota in the custody of Respondent Wardak.

(a)(5) in that Respondent Quick Tune & Brake, Inc. failed to competently inspect the brake and lighting systems on the Bureau's 2007 Toyota and issued certificates of compliance for brake adjustment and lamp adjustment when both the brake and lighting systems contained obvious defects that should have prevented them from passing the inspections. By failing to adhere to the inspection and certification criteria specified in the Bureau's Handbooks for Brake and Lamp Adjusters, including failing to remove the headlamp adjusters to inspect the headlamps, Respondent Quick Tune & Brake, Inc. was grossly negligent. The circumstances are more fully explained in paragraphs 56-60, above.

TWENTIETH CAUSE FOR DISCIPLINE

(Failure to comply with Automotive Repair Act)

- 64. Respondent Quick Tune & Brake, Inc. has subjected its Automotive Repair Dealer Registration to disciplinary action for failing to comply with the Automotive Repair Act under Code section 9884.7, subdivision (a)(6) in that Respondent Quick Tune & Brake, Inc. failed to properly perform brake and lamp inspections on the Bureau's 2007 Toyota. In doing so, Respondent failed to comply with provisions of the Code in the following material respects:
- a. <u>Code section 9889.16</u>: Respondent issued Brake Certificate of Compliance Number BA 3001144 and Lamp Certificate of Compliance Number No. LA 2962929 for the Bureau's 2007 Toyota; however, the vehicle did not comply with Vehicle Code requirements or Bureau regulations.
- b. <u>Code section 9889.22</u>: Respondent willfully made false statements or entries on Brake Certificate of Compliance BA 3001144 and Lamp Certificate of Compliance Number No. LA 2962929, in violation of the Automotive Repair Act.

The circumstances establishing Respondent's failure to comply with the Automotive Repair Act are more fully explained in paragraphs 56-60, above.

TWENTY-FIRST CAUSE FOR DISCIPLINE

(Willful Departure from Accepted Trade Standards)

65. Respondent Quick Tune & Brake, Inc. has subjected its Automotive Repair Dealer Registration to disciplinary action for willfully departing from or disregarding accepted trade

Respondent Wardak has subjected his smog check inspector license to disciplinary action pursuant to Health and Safety Code section 44072.2, subdivision (d), in that Respondent Wardak committed dishonest, fraudulent, and/or deceitful acts resulting in the injury to another, as more fully set forth in paragraphs 56-60, above.
- 76. Respondent Wardak has subjected his smog check repair technician license to disciplinary action pursuant to Health and Safety Code section 44072.2, subdivision (d), in that Respondent Wardak committed dishonest, fraudulent, and/or deceitful acts resulting in the injury to another, as more fully set forth in paragraphs 56-60, above.

THIRD INCIDENT/ FIELD VISIT: MAY 31, 2019

77. On May 31, 2019, a Bureau field inspector (inspector) made a field visit to Quick Tune & Brake, Inc. to perform a periodic Brake inspection. The inspector met with Respondent Wardak and obtained brake certificate books from Respondent Wardak, which documented Respondent Wardak's service history specific to his brake adjuster license. Respondent Wardak's brake adjuster license, BA 30707, expired on August 31, 2018. The inspector identified 372 Certificates of Adjustment – Brake Adjustment that Respondent Wardak performed without a valid brake adjuster license.

THIRTIETH CAUSE FOR DISCIPLINE

(Operating with an Expired License)

78. Respondent Quick Tune & Brake, Inc. has subjected its Automotive Repair Dealer Registration to disciplinary action for operating with an expired license under Code section 9887.1, subdivision (a) in that Respondent Quick Tune & Brake, Inc. continued to Issue Certificates of Adjustment –Brake adjustment without a valid brake adjuster license. The circumstances are more fully explained in paragraph 77, above.

THIRTY-FIRST CAUSE FOR DISCIPLINE

(Failure to Surrender Brake Station License)

79. Respondent Quick Tune & Brake, Inc. has subjected its Automotive Repair Dealer Registration to disciplinary action for failing to surrender its brake station license and return all unused brake certificates of adjustment to the Bureau in a timely manner, in violation of California Code of Regulations section 3308, subdivision (a). The circumstances are more fully explained in paragraph 75, above.

OTHER MATTERS

- 80. Under Code section 9884.7, subdivision (c), the Director may suspend, revoke, or place on probation the registration for all places of business operated in this state by Quick Tune & Brake, Inc. or Shafiullah Shirzoy Wardak, President upon a finding that they engaged in a course of repeated and willful violations of the laws and regulations pertaining to an automotive repair dealer.
- 81. Under Code section 9889.9, if Official Lamp Station License Number LS 267117, issued to Shafiullah Shirzoy Wardak, President of Quick Tune & Brake, Inc., is revoked or suspended, any additional license issued under Articles 5 and 6 of Chapter 20.3 of Division 3 of the Code in the name of said licensee may be likewise revoked or suspended by the Director.
- 82. Under Code section 9889.9, if Official Brake Station License Number BS 267117, issued to Shafiullah Shirzoy Wardak, President of Quick Tune & Brake, Inc., is revoked or suspended, any additional license issued under Articles 5 and 6 of Chapter 20.3 of Division 3 of the Code in the name of said licensee may be likewise revoked or suspended by the Director.
- 83. Under Code section 9889.9, if Lamp Adjuster License Number LA 30707, issued to Shafiullah Shirzoy Wardak, is revoked or suspended, any additional license issued under Articles 5 and 6 of Chapter 20.3 of Division 3 of the Code in the name of said licensee may be likewise revoked or suspended by the Director.
- 84. Under Code section 9889.9, if Brake Adjuster License Number BA 30707, issued to Shafiullah Shirzoy Wardak, is revoked or suspended, any additional license issued under Articles

5 and 6 of Chapter 20.3 of Division 3 of the Code in the name of said licensee may be likewise revoked or suspended by the Director.

PRAYER

WHEREFORE, Complainant requests that a hearing be held on the matters alleged in this Accusation, and that following the hearing, the Director of Consumer Affairs issue a decision:

- 1. Revoking or suspending Automotive Repair Dealer Registration Number ARD 267117, issued to Shafiullah Wardak, President, doing business as Quick Tune & Brake, Inc.;
- 2. Revoking or suspending any other Automotive Repair Dealer Registration issued to Quick Tune & Brake, Inc. or Shafiullah Wardak;
- 3. Revoking or suspending Lamp Station License Number LS 267117, issued to Shafiullah Wardak, President, doing business as Quick Tune & Brake, Inc.;
- 4. Revoking or suspending Brake Station License Number BS 267117, issued to Shafiullah Wardak, President, doing business as Quick Tune & Brake, Inc.;
- 5. Revoking or suspending Smog Check Station License Number RC 267117, issued to Shafiullah Wardak, President, doing business as Quick Tune & Break Inc.;
- 6. Revoking or suspending Smog Check Inspector License Number EO 30707, issued to Shafiullah S. Wardak;
- 7. Revoking or suspending Smog Check Repair Technician License Number EI 30707, issued to Shafiullah S. Wardak.;
- 8. Revoking or suspending Brake Adjuster License Number BA 30707, class C, issued to Shafiullah S. Wardak;
- 9. Revoking or suspending Lamp Adjuster License Number LA 30707, class A, issued to Shafiullah S. Wardak;
- 10. Revoking or suspending any additional license issued under Chapter 5 of Part 5 of Division 26 of the Health and Safety Code in the name of Shafiullah S. Wardak;
- 11. Revoking or suspending any other license issued under Article 5 and 6, Chapter 20.3 of Division 3 in the name of Shafiullah S. Wardak;
