1 Complainant alleges:

2 **PARTIES/LICENSE INFORMATION**

3 1.e Patrick Dorais (Complainant) brings this Accusation solely in his official capacity as  
4 the Chief of the Bureau of Automotive Repair, Department of Consumer Affairs.

5 **Jon Kayajian dba Smog Stop & Repair**

6 2.e On or about September 29, 2014, the Bureau of Automotive Repair issued Automotive  
7 Repair Dealer Registration Number ARD 278017 to Jon Kayajian dba Smog Stop & Repair  
8 (Respondent). The Automotive Repair Dealer Registration was in full force and effect at all times  
9 relevant to the charges brought herein and will expire on September 30, 2019, unless renewed.

10 3.e On or about September 24, 2015, the Bureau of Automotive Repair issued Smog Check  
11 Station License Number RC 278017 to Jon Kayajian dba Smog Stop & Repair. The Smog Check  
12 Station License was in full force and effect at all times relevant to the charges brought herein and  
13 will expire on September 30, 2019, unless renewed.

14 4.e On or about October 2, 2015, the Bureau of Automotive Repair issued STAR Station  
15 Certification to Jon Kayajian dba Smog Stop & Repair. The STAR Station certification will remain  
16 active unless the Automotive Repair Dealer registration and/or Smog Check Station license is  
17 revoked, canceled, licenses become delinquent or certification is invalidated.

18 5.e On or about September 21, 2015, the Bureau of Automotive Repair issued Lamp  
19 Station License Number LS 278017 to Jon Kayajian dba Smog Stop & Repair. The Lamp Station  
20 License was in full force and effect at all times relevant to the charges brought herein and will  
21 expire on September 30, 2019, unless renewed.

22 6.e On or about September 24, 2015, the Bureau of Automotive Repair issued Brake  
23 Station License Number BS 278017 to Jon Kayajian dba Smog Stop & Repair. The Brake Station  
24 License was in full force and effect at all times relevant to the charges brought herein and will  
25 expire on September 30, 2019, unless renewed.

1 14.e Bus. & Prof. Code section 9889.1 provides, in pertinent part, that the Director may  
2 suspend or revoke any license issued under Articles 5 and 6 (commencing with section 9887.1) of  
3 the Automotive Repair Act.

4 15.e Bus. & Prof. Code section 9889.7 provides, in pertinent part, that the expiration or  
5 suspension of a license by operation of law or by order or decision of the Director or a court of law,  
6 or the voluntary surrender of a license shall not deprive the Director of jurisdiction to proceed with  
7 any disciplinary proceedings.

8 16.e Health and Safety Code ("Health & Saf. Code") section 44002 provides, in pertinent  
9 part, that the Director has all the powers and authority granted under the Automotive Repair Act  
10 for enforcing the Motor Vehicle Inspection Program.

11 17.e Health & Saf. Code section 44072.6 provides, in pertinent part, that the expiration or  
12 suspension of a license by operation of law, or by order or decision of the Director of Consumer  
13 Affairs, or a court of law, or the voluntary surrender of the license shall not deprive the Director of  
14 jurisdiction to proceed with disciplinary action.

15 **STATUTORY PROVISIONS**

16 18.e Bus. & Prof. Code section 9884.7 states, in pertinent part:e

17 (a)eThe director, where the automotive repair dealer cannot show there was  
18 a bona fide error, may deny, suspend, revoke or place on probation the registration of  
19 an automotive repair dealer for any of the following acts or omissions related to the  
20 conduct of the business of the automotive repair dealer, which are done by the  
automotive repair dealer or any automotive technician, employee, partner, officer, or  
member of the automotive repair dealer.

21 (1)e Making or authorizing in any manner or by any means whatever any  
22 statement written or oral which is untrue or misleading, and which is known, or which  
by the exercise of reasonable care should be known, to be untrue or misleading.

23 . . . .

24 (4)eAny other conduct that constitutes fraud.e

25 . . . .

26 (6)eFailure in any material respect to comply with the provisions of this  
chapter or regulations adopted pursuant to it.

27 . . . .

28 (c)eNotwithstanding subdivision (b), the director may suspend, revoke or

1 place on probation the registration for all places of business operated in this state by an  
2 automotive repair dealer upon a finding that the automotive repair dealer has, or is,  
engaged in a course of repeated and willful violations of this chapter, or regulations  
adopted pursuant to it.

3 19.e Bus. & Prof. Code section 9889.3 states, in pertinent part:e

4 The director may suspend, revoke, or take other disciplinary action against  
5 a license as provided in this article [Article 7 (commencing with section 9889.1) of the  
Automotive Repair Act] if the licensee or any partner, officer, or director thereof:

6 . . . .

7 (c)e Violates any of the regulations promulgated by the director pursuant to e  
8 this chapter.

9 (d)e Commits any act involving dishonesty, fraud, or deceit whereby  
another is injured . . .

10 20. e Bus. & Prof. Code section 9889.9 states that “[w]hen any license has been revoked or e  
11 suspended following a hearing under the provisions of this article [Article 7 (commencing with  
12 section 9889.1) of the Automotive Repair Act], any additional license issued under Articles 5 and  
13 6 of this chapter in the name of the licensee may be likewise revoked or suspended by the director.”

14 21. Bus. & Prof. Code section 22, subdivision (a), states:

15 “Board” as used in any provision of this Code, refers to the board in which  
16 the administration of the provision is vested, and unless otherwise expressly provided,  
17 shall include “bureau,” “commission,” “committee,” “department,” “division,”  
“examining committee,” “program,” and “agency.”

18 22.e Bus. & Prof. Code section 477, subdivision (b), states, in pertinent part, that a “license” e  
19 includes “registration” and “certificate.”

20 23.e Health & Saf. Code section 44072.2 states, in pertinent part:e

21 The director may suspend, revoke, or take other disciplinary action against  
22 a license as provided in this article if the licensee, or any partner, officer, or director  
thereof, does any of the following:

23 (a)e Violates any section of this chapter [the Motor Vehicle Inspection  
24 Program (Health and Saf. Code § 44000, et seq.)] and the regulations adopted pursuant  
to it, which related to the licensed activities.

25 . . . .

26 (c)e Violates any of the regulations adopted by the director pursuant to this e  
27 chapter.

28 (d)e Commits any act involving dishonesty, fraud, or deceit whereby e

another is injured . . .

1  
2 24.e Health & Saf. Code section 44072.8 states that when a license has been revoked or  
3 suspended following a hearing under this article, any additional license issued under this chapter in  
4 the name of the licensee may be likewise revoked or suspended by the director.

5 **COST RECOVERY**

6 25.e Bus. & Prof. Code section 125.3 provides, in pertinent part, that a Board may request  
7 the administrative law judge to direct a licentiate found to have committed a violation or violations  
8 of the licensing act to pay a sum not to exceed the reasonable costs of the investigation and  
9 enforcement of the case.

10 **SMOG CHECK PROGRAM**

11 26.e California's Smog Check Program requires owners of most motor vehicles, in the  
12 enhanced and basic areas of the State, to subject their vehicles to a Smog Check inspection where  
13 they would receive a Certificate of Compliance. Said required inspection is to be performed every  
14 two years, when renewing their registration, and also when the vehicle's title is transferred. These  
15 inspections are performed by Smog Check Inspectors at Smog Test Stations, both of which are  
16 licensed by the Bureau. The Smog Check Program is designed and intended to reduce air pollution  
17 by identifying and requiring the repair of polluting motor vehicles.

18 **INQUIRY INTO THE SMOG CHECK ACTIVITIES OF JON KAYAJIAN DBA**  
19 **SMOG STOP & REPAIR**

20 27.e On or around March 13, 2018, a Program Representative for the Bureau conducted a  
21 detailed review of the Bureau's Vehicle Information Data (VID) for Smog Check inspections  
22 performed at Respondent Smog Stop & Repair. The review showed a pattern of vehicles being  
23 certified with a different electronic vehicle identification number (eVIN) as substitutes for the  
24 vehicles purportedly being tested. Review into the Smog Check activities at Respondent Smog

27 ///

1 Stop & Repair revealed that four (4) Smog Check Certificates of Compliance were issued to  
2 vehicles using the clean plugging method<sup>1</sup>.

3 **#1 2011 TOYOTA TACOMA DOUBLE CAB**

4 28.o On May 27, 2017, Respondent Kayajian issued a Smog Certificate of Compliance to a  
5 2011 Toyota Tacoma Double Cab, VIN #5TFJX4GNXBX002325. The On-Board Diagnostic  
6 Inspection System (OIS) data for this vehicle indicates that the eVIN was transmitted as  
7 #5TEJU62N88Z483060. Additional OIS data indicates that VIN #5TEJU62N88Z483060  
8 corresponds to a 2008 Toyota Double Cab Prerunner, which was certified by Ara Eskenian at Smog  
9 Stop & Repair on May 30, 2017. This 2008 Toyota was the vehicle used to generate the fraudulent  
10 Smog Certificate of Compliance for the 2011 Toyota.  
11

12 **#2 2009 NISSAN ALTIMA 2.5**

13 29.o On June 1, 2017, Respondent Kayajian issued a Smog Certificate of Compliance to a  
14 2009 Nissan Altima 2.5, VIN #1N4AL21E99N402896. The OIS data for this vehicle indicates that  
15 the eVIN was transmitted as #1C6RR6KT2DS716651. Additional OIS data indicates that VIN  
16 #1C6RR6KT2DS716651 corresponds to a 2013 Dodge Ram 1500 ST, which was certified by  
17 Respondent Kayajian at Smog Stop & Repair on June 1, 2017. This 2013 Dodge was the vehicle  
18 used to generate the fraudulent Smog Certificate of Compliance for the 2009 Nissan.  
19

20 **#3 2008 Toyota Prius**

21 30.o On July 19, 2017, Respondent Kayajian issued a Smog Certificate of Compliance to a  
22 2008 Toyota Prius, VIN #JTDKB20U787720934. The OIS data for this vehicle indicates that the  
23 eVIN was transmitted as #JTDKB20U293481236. Additional OIS data indicates that VIN #  
24 JTDKB20U293481236 corresponds to a 2009 Toyota Prius, which was certified by Respondent  
25

27 <sup>1</sup> "Clean Plugging" is a method by which another vehicle's properly functioning On-Board  
28 Diagnostics (OBDII) functional test system, or another source, is used to generate passing data  
readings or diagnostic information for the purpose of fraudulently issuing smog certificates to  
vehicles that are not in smog compliance and or not present for testing.

1 Kayajian at Smog Stop & Repair on August 2, 2017. This 2009 Toyota was the vehicle used to  
2 generate the fraudulent Smog Certificate of Compliance for the 2008 Prius.

3 **#4 2015 Toyota Tacoma Access Cab**

4 31.e On November 3, 2017, Respondent Kayajian issued a Smog Certificate of Compliance  
5 to a 2015 Toyota Tacoma Access Cab, VIN #5TFTX4CN8FX056517. The OIS data for this  
6 vehicle indicates that the eVIN was transmitted as #5TFTX4CN5FX048536. Additional OIS data  
7 indicates that VIN #5TFTX4CN5FX048536 corresponds to a different Toyota Tacoma Access  
8 Cab, which was certified by Ara Eskenian at Smog Stop & Repair on December 4, 2017. The other  
9 Toyota was the vehicle used to generate the fraudulent Smog Certificate of Compliance for the  
10 Toyota on November 3, 2017.

12 **UNDERCOVER OPERATION: 2005 HONDA**

13 32.e On October 16, 2018, an operator of the Bureau (operator) took the Bureau's 2005  
14 Honda (2005 Honda) to Smog Brake & Lamp and requested a Smog Check Inspection. The  
15 catalytic converter had been removed from the 2005 Honda. The 2005 Honda was inspected and  
16 certified under the Smog Check Inspector license of Respondent Kayajian as indicated by the  
17 Vehicle Inspection Report (VIR) from Bureau records and was issued Certificate of Compliance  
18 [REDACTED] The operator paid \$60 for the Smog Check Inspection and received a copy of  
19 invoice [REDACTED] and a VIR.

21 33.e On November 15, 2018, the Bureau re-inspected the 2005 Honda and verified the  
22 catalytic converter was still missing.

24 **FIRST CAUSE FOR DISCIPLINE**

25 **(Fraud)**

26 34.e Respondent Smog Stop & Repair's registration is subject to disciplinary actions  
27 pursuant to Bus. & Prof. Code section 9884.7, subdivision (a)(4), Respondent committed acts  
28 constituting fraud, as follows:



1e a. Respondent issued electronic smog certificates of compliance for a 2011 Toyota  
2 Tacoma, a 2009 Nissan Altima 2.5, a 2008 Toyota Prius, a 2015 Toyota Tacoma Access Cab and  
3 2005 Honda without ensuring that bona fide inspections were performed of the emission control  
4 devices and systems on the vehicles, thereby depriving the People of the State of California of the  
5 protection afforded by the Motor Vehicle Inspection Program. Complainant incorporates the  
6 allegations of paragraphs 27 through 33 as set forth herein.

7 **SECOND CAUSE FOR DISCIPLINE**

8 **(Dishonesty, Fraud, or Deceit)**

9 35.e Respondent Smog Stop & Repair's Brake and Lamp station license is subject to  
10 disciplinary action pursuant to Bus. & Prof. Code section 9889.3, subdivision (d), in that  
11 Respondent committed acts involving dishonesty, fraud, or deceit whereby another was injured, as  
12 set forth in paragraphs 27 through 33 above.

13 **THIRD CAUSE FOR DISCIPLINE**

14 **(Violations of the Motor Vehicle Inspection Program)**

15 36.e Respondent Smog Stop & Repair's smog check station license is subject to disciplinary  
16 action pursuant to Health & Saf. Code section 44072.2, subdivision (a), in that Respondent failed  
17 to comply with the following sections of that Code:

18 a. **Section 44015:** Respondent issued five (5) electronic smog certificates of compliance  
19 without properly testing and inspecting the vehicles to determine if they were in compliance with  
20 Health & Saf. Code section 44012. Complainant incorporates the allegations of paragraphs 27  
21 through 33 as set forth herein.

22 **FOURTH CAUSE FOR DISCIPLINE**

23 **(Failure to Comply with Regulations Pursuant  
24 to the Motor Vehicle Inspection Program)**

25 37.e Respondent Smog Stop & Repair's smog check station license is subject to disciplinary  
26 action pursuant to Health & Saf. Code section 44072.2, subdivision (c), in that Respondent failed  
27 to comply with the following sections of California Code of Regulations, title 16:

28 ///

1 a. **Section 3340.35, subdivision (c):** Respondent issued five (5) electronic smog  
2 certificates of compliance even though the vehicles had not been inspected in accordance with  
3 section 3340.42.

4 b. **Section 3340.42:** Respondent failed to ensure that the required smog tests were  
5 conducted on five (5) vehicles in accordance with the Bureau's specifications. Complainant  
6 incorporates the allegations of paragraphs 27 through 33 as set forth herein.

7 **FIFTH CAUSE FOR DISCIPLINE**

8 **(Failure to Comply with Regulations Pursuant  
9 to the Motor Vehicle Inspection Program)**

10 38.o Respondent Kayajian's Smog Check Inspector and Smog Check Repair Technician  
11 licenses are subject to disciplinary action pursuant to Health & Saf. Code section 44072.2,  
12 subdivision (c), in that Respondent failed to comply with provisions of California Code of  
13 Regulations, title 16, as follows:

14 a. **Section 3340.42:** Respondent failed to conduct the required smog tests on five (5)  
15 vehicles in accordance with the Bureau's specifications. Complainant incorporates the allegations  
16 of paragraphs 27 through 33 as set forth herein.

17 **SIXTH CAUSE FOR DISCIPLINE**

18 **(Dishonesty, Fraud or Deceit)**

19 39.o Respondent Kayajian's Smog Check Inspector and Smog Check Repair Technician  
20 licenses are subject to disciplinary action pursuant to Health & Saf. Code section 44072.2,  
21 subdivision (d), in that Respondent committed a dishonest, fraudulent, or deceitful act whereby  
22 another is injured by issuing five (5) electronic smog certificates of compliance without performing  
23 a bona fide inspection of the emission control devices and systems on the vehicles, thereby  
24 depriving the People of the State of California of the protection afforded by the Motor Vehicle  
25 Inspection Program. Complainant incorporates the allegations of paragraphs 27 through 33 as set  
26 forth herein.

27 ///

1 **SEVENTH CAUSE FOR DISCIPLINE**

2 **(Dishonesty, Fraud or Deceit)**

3 40.e Respondent Kayajian's Brake and Lamp Adjuster licenses are subject to disciplinary  
4 action pursuant to Bus. & Prof. Code section 9889.3, subdivision (d), in that Respondent committed  
5 a dishonest, fraudulent, or deceitful act whereby another is injured by issuing a Certificate of  
6 Compliance for the 2005 Honda without performing a bona fide inspection of the emission control  
7 devices and systems on the vehicle, thereby depriving the People of the State of California of the  
8 protection afforded by the Motor Vehicle Inspection Program. Complainant incorporates the  
9 allegations of paragraphs 32 through 33 as set forth herein.

10 **EIGHTH CAUSE FOR DISCIPLINE**

11 **(Untrue or Misleading Statements)**

12 41.e Respondent Smog Stop & Repair's registration is subject to disciplinary action  
13 pursuant to Bus. & Prof. Code section 9884.7, subdivision (a)(1), Respondent made or authorized  
14 statements which he knew or in the exercise of reasonable care should have known to be untrue or  
15 misleading, as follows:

16 a.e Respondent issued electronic smog certificates of compliance for a 2011 Toyota  
17 Tacoma, a 2009 Nissan Altima 2.5, a 2008 Toyota Prius and a 2015 Toyota Tacoma Access Cab.  
18 In fact, Respondent failed to perform inspections of the emission control devices and systems on  
19 the vehicles. Complainant incorporates the allegations of paragraphs 27 through 33 as set forth  
20 herein.

21 **MATTERS IN AGGRAVATION**

22 42.e To determine the degree of discipline, if any, to be imposed on Respondents,  
23 Complainant alleges as follows:

24 a.e On or about January 26, 2018, the Bureau issued Citation No. C2018-586 against  
25 Respondent Jon Kayajian dba Smog Stop & Repair for violations of Health and Saf. Code section  
26 44012. On or about January 10, 2018, Respondent issued a Certificate of Compliance to a Bureau  
27 Undercover Vehicle with a missing or modified Positive Crankcase Ventilation System. The  
28

1 Bureau assessed civil penalties against Respondent for the violation. Respondent paid the fine on  
2 March 22, 2018.

3 b.e On or about April 28, 2016, the Bureau issued Citation No. C2016-0886 against  
4 Respondent Jon Kayajian dba Smog Stop & Repair for violations of Health and Saf. Code section  
5 44012. On or around July 7, 2015, Respondent issued a Certificate of Compliance to a 1999 Ford  
6 Diesel using the BAR97 when an OBD Inspection System was required. Citation was dismissed by  
7 the Bureau on July 14, 2016.

8 c. On or about January 26, 2018, the Bureau issued Citation No. M2018-587 against  
9 Respondent Jon Kayajian for violations of Health and Saf. Code section 44032. Respondent  
10 inspected and certified a vehicle with missing or modified Positive Crankcase Control (PCV)  
11 components.

12 d.e On or about April 28, 2016, the Bureau issued Citation No. M2016-0887 against  
13 Respondent Jon Kayajian for violations of Health and Saf. Code section 44012. Respondent issued  
14 a Certificate of Compliance using the BAR97 when an OBD Inspection System was required.  
15 Citation was dismissed by the Bureau.

16 **OTHER MATTERS**

17 43.e Pursuant to Bus. & Prof. Code section 9884.7, subdivision (c), the Director may  
18 suspend, revoke or place on probation the registration for all places of business operated in this  
19 state by Respondent Smog Stop & Repair upon a finding that Respondent has, or is, engaged in a  
20 course of repeated and willful violations of the laws and regulations pertaining to an automotive  
21 repair dealer.

22 44.e Pursuant to Health & Saf. Code section 44072.8, if Smog Check Station License  
23 Number RC 278017, issued to Respondent Smog Stop & Repair, is revoked or suspended, any  
24 additional license issued under Chapter 5 of the Health & Saf. Code in the name of said licensee  
25 may be likewise revoked or suspended by the Director.

26 45.e Pursuant to Bus. & Prof. Code section 9889.9, if Lamp Station License Number

27 ///

28 ///

1 LS 278017, issued to Respondent Smog Stop & Repair, is revoked or suspended, any additional  
2 license issued under Articles 5 and 6 of Chapter 20.3 of the Bus. & Prof. Code in the name of said  
3 licensee may be likewise revoked or suspended by the Director.

4 46.e Pursuant to Bus. & Prof. Code section 9889.9, if Brake Station License Numbere  
5 BS 278017, issued to Respondent Smog Stop & Repair, is revoked or suspended, any additional  
6 license issued under Articles 5 and 6 of Chapter 20.3 of the Bus. & Prof. Code in the name of said  
7 licensee may be likewise revoked or suspended by the Director.

8 47.e Pursuant to Health & Saf. Code section 44072.8, if Smog Check Inspector Licensee  
9 Number EO 636082, issued to Respondent Jon Kayajian, is revoked or suspended, any additional  
10 license issued under Chapter 5 of the Health & Saf. Code in the name of said licensee may be  
11 likewise revoked or suspended by the Director.

12 48.e Pursuant to Health & Saf. Code section 44072.8, if Smog Check Repair Technician  
13 License Number EI 636082, issued to Respondent Jon Kayajian, is revoked or suspended, any  
14 additional license issued under Chapter 5 of the Health & Saf. Code in the name of said licensee  
15 may be likewise revoked or suspended by the Director.

16 49.e Pursuant to Bus. & Prof. Code section 9889.9, if Brake Adjuster License Numbere  
17 BA 636082, issued to Respondent Jon Kayajian is revoked or suspended, any additional license  
18 issued under Articles 5 and 6 of Chapter 20.3 of the Bus. & Prof. Code in the name of said licensee  
19 may be likewise revoked or suspended by the Director.

20 50.e Pursuant to Bus. & Prof. Code section 9889.9, if Lamp Adjuster License Numbere  
21 LA 636082, issued to Respondent Jon Kayajian, is revoked or suspended, any additional license  
22 issued under Articles 5 and 6 of Chapter 20.3 of the Bus. & Prof. Code in the name of said licensee  
23 may be likewise revoked or suspended by the Director.

24 **PRAYER**

25 WHEREFORE, Complainant requests that a hearing be held on the matters herein alleged,  
26 and that following the hearing, the Director of Consumer Affairs issue a decision:

27 1.e Revoking or suspending Automotive Repair Dealer Registration Number ARDe  
28 278017, issued to Jon Kayajian dba Smog Stop & Repair;

- 1           2.e   Revoking or suspending any other automotive repair dealer registration issued to
- 2 Jon Kayajian dba Smog Stop & Repair;
- 3           3.e   Revoking or suspending Smog Check Station License Number RC 278017, issued to
- 4 Jon Kayajian dba Smog Stop & Repair;
- 5           4.e   Revoking or suspending Lamp Station License Number LS 278017, issued to Jon
- 6 Kayajian dba Smog Stop & Repair;
