ARD Citation/Remedial Training (1 of 3)

Status of proposed regulations:

- On March 7, 2023, the regulation text and final phase documents were submitted to OAL and DOF
- On April 14, 2023, DOF signed off on the regulation package
- On April 19, 2023, OAL requested a correction requiring an additional 15-day comment period
- Adoption is on track for May 31, 2023, with an effective date on July 1, 2023
- On April 27, 2023, BAR gave a presentation regarding the citation review conference process

Status of implementation:

- Citation Program
 - Created new CAS codes for the citation program
 - Created an ARD citation template
 - Still waiting on DCA for changes to posting algorithm

ARD Citation/Remedial Training (2 of 3)

Status of implementation (cont.):

- Citation Review Panel
 - Created applications for industry and consumer panel members
 - Created a panel member reference guide
 - Created panel member orientation training
 - Created citation review panel decision letter in ARDIS
- Remedial Training
 - Created an application for remedial training provider certification
 - Made necessary changes to CalARC to accommodate remedial training providers, remedial training classes, and the new certificates of completion

ARD Citation/Remedial Training (3 of 3)

Pending implementation items:

- EOB procedures for managing and conducting citation review conferences
- Field Operations procedures/guidelines for citations and dissemination to field staff

ARD Application/Educational Certifications

Status of proposed regulations:

- On March 17, 2023, the regulation text/final phase documents were submitted to OAL
- OAL review due by 5/1
 - In January 2023, created a 2nd regulation package to require the additional information (email address, educational certifications) from an ARD on renewal
 - On April 17, 2023, DCA Legal approved the initial filing phase documents
 - Next step file with OAL and begin the 45-day comment period

Status of implementation:

- Process for accepting educational certifications through the ARD application process is part of ELM
- Changes being made to Auto Shop Locator to display certifications

Vehicle Safety Systems Inspection Program (1 of 2)

Status of proposed regulations:

- On March 9, 2023, DCA Legal approved the regulation text and inspection manual
- On April 27, 2023, BAR conducted a 3rd public workshop on this program
- Currently working on initial filing phase documents with a goal of submission to DCA Legal for review by May 12, 2023.

Status of implementation:

- BAR-SIS
 - OnCore is creating the BAR-SIS that will be housed with BAR-OIS on the CalVIS
 - BAR-SIS software is to be deployed to existing BAR-OIS analyzers in 4 updates throughout 2023

Vehicle Safety Systems Inspection Program (2 of 2)

Status of implementation (cont.):

- The 1st release "23.1" which covers BAR-OIS and BAR-SIS shared functionality is currently in user acceptance testing and is set to be deployed in mid-May 2023
- The 2nd release "23.2" which covers the vehicle safety systems inspection process is set for user acceptance testing in June 2023, with a projected deployment in August 2023
- 5 SMEs are beginning to write test scripts for testing the 23.2 release based on their assigned chapter(s) from the Vehicle Safety Systems Inspection Manual
