





FY 2018-19 YTD ENGINE REPAIR & ENGINE PERFORMANCE: Total 2174*




FY 2017-18 YTD ENGINE REPAIR & ENGINE PERFORMANCE: Total 2253*




FY 2018-19 YTD GENERAL REPAIR & MAINTENANCE: Total 1241*


















FY 2017-18 YTD SMOG: Total 495*




COMPLAINT ALLEGATIONS – USED CAR TRANSACTIONS







COMPLAINT ALLEGATIONS – VEHICLE WARRANTY




FY 2017-18 YTD VEHICLE WARRANTY: Total 172*
